Terms & Conditions

- If a SwipeSimple reseller has opted out of this program, entries submitted by their employees or sales partners will not be eligible.
- Only new SwipeSimple Terminal merchant accounts boarded between November 1 and December 31, 2019, qualify for entry.
- If the same merchant receives multiple terminals, only the first terminal is eligible for the incentive

- Only SwipeSimple Terminal deployments are eligible. SwipeSimple mobile and gateway merchant account deployments do not qualify for the incentive.
